Play Console Requirements

Developers need to register as an Organization if they provide the following: Financial Products, Medical Services, VPN Functionality, and Government Services. Effective for new developers starting August 31.

Minimum Functionality

We are renaming the policy to Spam, Functionality, and User Experience, and updating this will allow users to see that our catalog is full of only quality apps that function with high performance.

SDK Requirements

We're updating the SDK Requirements page with additional examples of SDK-caused policy violations for Spyware and Foreground Services, to help clarify the impact of using third-party SDKs in apps.

SDK Malware Actor

We've added an update to clarify how developers who use third party SDKs might distribute malicious software that collect and abuse user and user device data.

Verify Your Developer Identity Information

From May 2024 to February 2025, developers can complete verifications in Play Console 60 days before their individual deadline. Developers must complete account verifications before the deadline to prevent their developer profile and apps being removed from Google Play.

Important Reminders

App testing requirements for new personal developer accounts

Developers with new personal accounts after November 13, 2023 are required to test their apps with at least 20 people for a minimum of two weeks before applying for access to production.

Helpful Tips to Get Your App Published on Google Play

- **Metadata:** Be clear and comprehensive with your store listing information
- **Deceptive Behavior:** Make sure your app delivers what it promises
- **Login Credentials:** Provide login information to help us review your app
- **Broken Functionality:** Ensure that your app works properly and try test tracks
- If your app gets rejected, fix the issue and resubmit

Detect App Issues Early with Pre-Review Checks

Pre-review checks help you catch potential problems with changes you plan to make to your app, before you send them for review. Examples are incomplete / invalid declarations, and technical quality checks.

New Badge for Government-Made Apps on Play Store

The badge is an icon of a building with the word “Government” underneath it, and can be seen to the right of the app rating. When you tap on the badge, it will open a message that says “Official government — Play verified this app is affiliated with a government entity.”

Government App Declaration Process on Play Store

Developers must complete the Government apps declaration on the App content page in Play Console. This allows the app to become eligible for official endorsement.

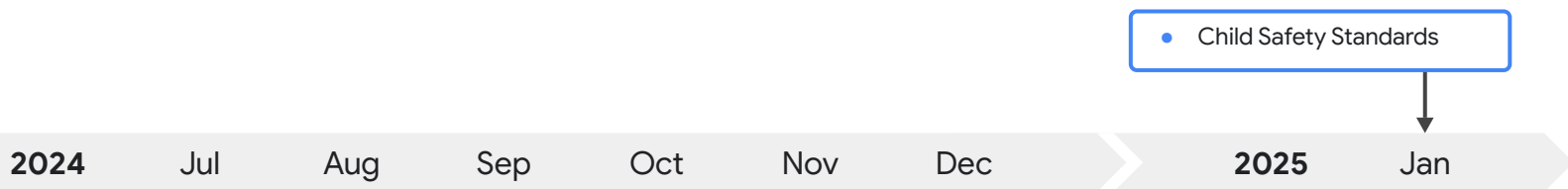
