Consent Banner and Consent Mode implementation steps





Get started in 3 easy steps

- Install the WordPress plugin and activate your license received by email after purchase
- Start the wizard and when selecting Analytics or Tag Manager proceed to enable Consent Mode
- Answer the questions about Consent Mode as specified in the wizard with help of documentation e.g. https://complianz.io/consent-mode-for-7-0/

Enabling Consent Mode is not much different than answering a Yes/No question, and Complianz should configure the inline scripts and the consent banner for this purpose. If users want to use the Tag Manager template they naturally need to be somewhat experienced in Tag Manager Tagging UI etc, but we have a definitive guide for Tag Manager on the website.

The consent banner can subsequently be customized, but is configured automatically based on the questions the user provided.



It takes 5 minutes in Complianz, but additional time can be added in Tag Manager if needed. Less if you're using Sitekit for WordPress
