FREE plan (free) - Best for small websites with a simple cookie consent banner, limited functionality:

- 10 pages scanned per domain
- 20.000 monthly pageviews

LITE plan (from €8 / month, 2 domains included) - Designed for bigger websites and covers the basic functionality

- 100 pages scanned per domain
- Unlimited monthly pageviews

STANDARD plan (from €15 / month, 2 domains included) - Includes automated processes to take care of the boring stuff

- 1000 pages scanned per domain
- Unlimited monthly pageviews

PLUS plan (from €19 / month, 2 domains included) - Most popular plan with all necessary compliance features included

- 3000 pages scanned per domain
- Unlimited monthly pageviews

Get started in 3 easy steps

- Create an account at <https://cookie-script.com/register>
- Follow a startup guide in the dashboard: enter your website URL, select banner design and language. CookieScript will automatically scan your website cookies and categorize them.
- Install CookieScript banner on the website:
 - With GTM: use Tag Template from the GTM Template Gallery and insert the banner URL from the Installation tab in the dashboard.
 - Without GTM: copy-paste one-line code snippet to your website.

Customers are expected to know how to install Tag Template from the GTM Template Gallery or have ability to paste one line of code on the website.



Typical time taken by a customer to implement a banner & CoMo is 5-10 minutes.
