
“Google Play Diamond Valley” Challenge
Sponsored by Google LLC
Official Rules - USA

NO PURCHASE, PAYMENT OR TRANSACTION NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT OR TRANSACTION OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTRY PERIOD

The “Google Play Diamond Valley” Challenge (the “**Challenge**” and the “**Promotion**”) is sponsored by Google LLC (the “**Sponsor**”) and will be construed according to U.S. law. The Sponsor is the sole determiner of Challenge compliance. The Challenge is scheduled to begin on **June 17, 2024** at 12:00:00 AM Pacific Time (“PT”) and ends on **July 15, 2024** at 11:59:59 PM Pacific Time (the “**Entry Period**”).

The Sponsor’s computer, or that of its designee, runs the official clock for the Challenge and will solely determine the time by which an entry is received. Entry into the Challenge does not constitute entry into any other Promotions administered by the Sponsor.

ELIGIBILITY

The Challenge is open to legal residents of the United States and the District of Columbia who are Eighteen (18) years of age or older. Void in Puerto Rico, Guam, the US Virgin Islands and other United States overseas territories, military institutions and wherever prohibited by law and are **Google Play members as of date of entry** (herein known as a “**Participant**” and “**Entrant**”). The Challenge is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law. AGREEMENT TO THE OFFICIAL RULES

HOW TO ENTER There is no purchase, transaction or payment necessary to enter.

View the Diamond Valley Challenge at https://diamondvalley.withgoogle.com/intl/ALL_us/. Sign in to your Google account (the “entry method”) to play. Follow instructions to complete the Challenge and collect Diamonds (the “Diamonds”). At the end of the Challenge, you can use the “Diamonds” that you collected to enter to win various prizes (an “Entry”). Required “Diamonds” to enter to win vary by prize. Select prizes are only available to Diamond and Platinum members of Google Play Points.

If a prize requires digital or mailing delivery, follow instructions to complete the registration form inclusive of: first name, last name, email address, mailing address, phone number and accept the terms and conditions. Upon completion, Entrant will receive one (1) entry into the Challenge (an “Entry”). You can enter for more than one prize. You may have multiple entries for the same prize to increase your chances of “winning”, but you can only “win” each prize once. Incomplete forms will be void and not be eligible for an entry. Upon submitting your Entry, you agree to be bound by these Official Rules.

ENTRY LIMITATIONS

On or about August 1, 2024, a random drawing will be conducted from among all eligible Entries received and randomly-drawn individuals (the “Potential Winner”) shall be selected under the supervision of the Sponsor, whose decisions are final and binding in all matters relating to this Challenge. NOTIFICATION

The potential winners will be notified by email (to the email address associated with the Entrant's account) on/or about August 7, 2024 by the Sponsor or their designee. Prizes will be shipped to randomly-drawn individuals ("Winners") on or about August 10, 2024.

All Participants and their legally defined heirs, executors, administrators and successors (individually and collectively, the "Releasing Parties"), as a condition of participation in this Challenge, agree to unconditionally and irrevocably here on out release, discharge, hold harmless and defend the Sponsor, and the Released Parties, from any liability, claims, litigation, losses, actions, or damages of any kind, whether actual, incidental or consequential, for injury (including but not limited to death), illness, damages, losses or expenses arising out of or relating to Participant's participation in this Challenge, or the acceptance, possession or use/misuse of any prize, or participation in prize-related activities.

By participating in this Challenge, Releasing Parties further agree to abide by and be bound wholly by the Official Rules and waive any right to claim any ambiguity or error therein or in this Challenge itself, and to be bound by the decisions of the Sponsor, which shall be final in all matters relating to this Challenge. If due to circumstances beyond the control of the Sponsor, any event associated with this Challenge that may impede awarding of the prize (in part/whole), the Sponsor reserves the right, but not the obligation, to cancel or modify the Challenge and shall not be required to award a substitute prize (in part/whole).
