Application Requirements for a Training Partner Service Authorization

How to Become a Google Cloud Training Partner

Training Partners are companies authorized to deliver instructor led training according to Google Cloud curriculum standards. Active Authorization under the Services Engagement model is needed and partners are expected to meet requirements as outlined in the Partner Advantage program guide along with any additional requirements for a Training Partner Authorization once onboarded. Companies may join by invitation only.
