## Evaluation Methods Used:

Evaluation of the product involved a combination of automated, manual, and functional testing against the applicable success criteria within the Web Content Accessibility Guidelines (WCAG) 2.2 Conformance Level A and AA. The application was tested using a set of use cases designed to cover the components and functionality of use flows. Assistive technologies used include: ChromeVox, JAWS, NVDA, and VoiceOver with the Chrome browser and platform assistive technologies for magnification, keyboard navigation, and dark mode on ChromeOS, Windows, and MacOS.
