## Get started in 5 easy steps

- 1. Log in and Access Cookie Consent: Go to Seers, log in, and click on the Cookie Consent option from the dashboard.
- 2. Add Your Domain and Open Preferences: In the Domain Manager, click Add Domain, enter your domain details (name, scan frequency, and email), then click Save.
- 3. Install the Banner Script: Access the Get Code page.

Choose to either:

- Manually insert the script into your site's <head> section, or
- Deploy it using Google Tag Manager.
- 4. Navigate to Preferences: After installing the banner, click customisation through the setup pages on your dashboard, and go to the Preferences tab on the Customise page.
- 5. Enable Google Consent Mode v2: Google Consent Mode v2 is enabled by default under Frameworks. Review the settings and click Save to confirm and apply any changes.
