- **Basic Plan(\$60 per month):** Supports GDPR compliance (up to 10,000 requests/month).
- **Plus Plan(\$120 per month):** Includes geo-targeting, UI text customization, and support for iOS & Android apps (up to 100,000 requests/month).

#### Pricing Structure:

- Charges are based on the number of domains and request counts.
- Domains are counted per naked domain (e.g., example.com).
- Additional charges apply if the request limits are exceeded.

### Get started in 3 easy steps

1. Sign Up for webtru
  - o Visit [webtru.io](http://webtru.io) and create an account.
2. Create a New Widget for Your Website
  - o In the webtru dashboard, enter the URL of your website where you want to implement consent management.
  - o Enable "Use Google Consent Mode" to ensure proper consent signal management.
3. Install the Widget Tag Using GTM
  - o In Google Tag Manager (GTM), add a New Tag using the webtru template.
  - o Paste the widget tag ID and enable "Google Consent Mode" in the tag settings.
  - o Set the trigger to Consent Initialization - All Pages, then save and publish.

Once set up, webtru will automatically manage consent signals and integrate with Google Consent Mode, ensuring compliance with privacy regulations.
